


## Why do we want to do things quickly?

- Implementation and funding deadlines




## Introduction to the EM theme


- Aims to develop, apply and support the best use of qualitative and quantitative methodologies in research.



## How do we do things quickly?

- Use methodological techniques to reduce time taken to collect and analyse data?
  - Adaptive trial design
  - Automated methods
  - Virtual data collection
  - Team-based approaches
  - Staged approach to evaluation
- But are our methods making our research slow?




# Review launched to reduce red tape for UK researchers

A new independent review into UK research bureaucracy will identify ways to free up researchers to pursue world class research.

#### Are there unique challenges in an ARC?

- Aim of increasing the rate at which research findings are put into practice and can benefit communities
- Brings together teams with diverse backgrounds, needs and expectations
- i.e. sometimes new ways of working






#### Why is scale important?

- Sometimes scale is non-negotiable e.g. trials, seeking saturation
- All research has finite resources
- Expectations need to be managed
- Evaluation on a shoestring can we think small?

- Supportive and flexible local and nationals systems facilitated by
- Our own skills/knowledge to navigate these systems

#### **Final reflections**

- Should we talk about responsive methods?
- Methods are one part of a research timeline which needs to be streamlined
- Challenges to development of methods alongside rapid delivery
- Collective learning as an applied research community is happening and we need to capture it
- Work with local systems to understand how processes can be streamlined
