# The Level 2 Award in Peer Research

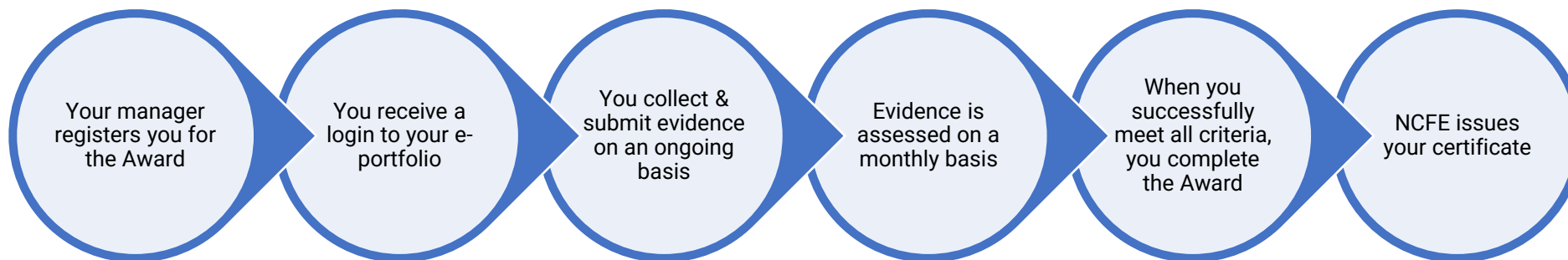

# The journey to achieving the Award

The main stages of the journey you will follow are shown in the diagram.



The time you have to complete the Award will depend on the duration of your role as a peer researcher and any requirements from your organisation. You should discuss with your manager/supervisor/mentor the time-frame within which you will need to gather and submit your evidence.

# The modules

**You will need to complete four modules:**

- Three compulsory modules
- One optional module

Depending on your organisation and peer research project, you may not have to decide which optional module you want to do at the start.

Until your manager/supervisor/mentor confirms which optional module you want to complete, you will see all modules in the e-portfolio.

# What evidence you need

**You should be able to produce most of the evidence you need through your day-to-day role as a peer researcher.** You will be able to submit examples of the work you have done, with short accompanying statements of explanation. For example:

- **Extracts from transcripts** – with examples of questions highlighted
- **Recruitment materials** – showing how information was provided
- **Photos or video** – eg of your role in a session, or role-play to show your skill

**Some modules will also require you to:**

- Complete a short online assessment
- Provide a statement from your manager to confirm that you did something

## Note:

The next section of the handbook covers each module and what we are looking for.

The term 'manager' covers a range of roles including supervisor and mentor but means the person at the organisation you work for/ volunteer with who supports you in your role.
